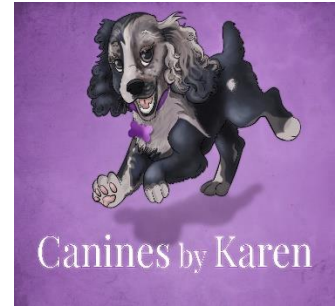

Who can compete in a trial? Any and all dogs that are 10 months or older, on the day of the trial or the Target Odor Test (TOT), are eligible to compete. All Dogs must have their current Rabies Vaccination and other vaccinations recommended by your veterinarian.

Do I Need to Register with PSD? PSD registers dogs not people. A \$30 registration fee is good for the lifetime of the dog and can be done instantly on-line.

What if I don't pass the TOT? You can still play!! Dogs must pass a Target Odor Test (TOT) in order to compete in the Standard Division, however if you do not pass you are still allowed to enter the trial as FEO (For Exhibition Only) for the day.

My dog has a Nose Work title from a different organization, do I have to pass a TOT? If you already have passed an odor test in another scent work organization, you do not have to take the TOT. Dogs with a NW3, SDDA Excellent or UKC Level 5 title may skip the Novice level and start PSD at the Advanced level. Please send a copy of your test results to info@performancescentdogs.com in order to register.

Can I watch other competitors? Yes you can watch, either after you run or you can watch a different level compete.

Can my friend videotape my searches? Yes! And you may post them anywhere you like.

Awards: Rosette placement ribbons will be awarded for 1st-3rd place. Ribbons will be awarded for Q's in all classes, including TOT's.

Collars Any collar is allowed on the grounds except scent spraying collars or electric collars. Only a flat, or martingale collar or leashes attached to a dead ring or harness are permitted to be used during a search. No tags on collars while searching. All dogs must be leashed at all times, except during an off-leash search while on trial grounds. There is an off-leash play yard available for dogs to use while being supervised (no dogs left unattended in the play yard).

Crating will be out of your car, under the trees, or bring a pop-up tent. There is ample space for everyone without anyone being crowded here at the farm.

Parking Huge parking area under the trees and on grass. Please watch for cone or signs indicating an area is off limits for parking-it may be a search area.

Spectators are invited to come and watch any PSD trial.

Volunteers will help our Trial run smoothly. We need Timers, Gate Stewards, Score Runners, and Others. No worries because no experience required! We are all brand new at this so we are all in the same boat!! No need to give up a day-volunteers get to run first in their class. Thanks in advance for your help.

Donations Canines By Karen is supporting a local low cost spay/neuter clinic. Please support the PPAWS by bringing in any amount of cash or checks made payable to PPAWS please.

Food We are in the country. Far from any fast food. We have a local diner that will deliver us food on Saturday around lunch (expect about \$10 per day) but they are closed on Sundays so please plan accordingly. We will have snacks and drinks available.

Bathrooms: Our indoor half-bath is available and is located in the retail area. This is a farm and a working dog training and event center so please plan your wardrobe (especially shoes) accordingly.

RVs and dry camping: RVs and tent campers are welcome. There are a couple of 30 amp hook-ups available if you bring a 75 plus foot cord (\$30 a night) or you are welcome to dry camp (\$15 a night).

Accessibility No stairs or steps for entry but traversing a slope with grass and gravel is required for access to the trial location.

Dogs In Need of Space The site has plenty of parking and places to walk dogs at a distance of 10 feet or more. There is a single entrance and exit for some searches that could be congested with people. Volunteers will be onsite to help escort participants to and from the search area. Red bandanas are not required-please give **all** dogs space.

Handler running multiple dogs A handler can run multiple dogs in TOTs at any trial/match. At this trial, a handler may run two dogs per class in Novice on Saturday, one dog per class in Novice on Sunday, and one dog per class in Advanced each day. Saturday Novice is our only split trial.
