Dogs may enter no more than **6 runs** (not counting TOT) If multi-level must be in different classes(1 or 2) i.e.:  
Novice Exterior 3, advanced Exterior 2 You may enter on-line or by mail - one entry per dog. All entries must  
be received by Dec 26 (unless we aren't full)

**Entry close date:** Dec 26 or when classes fill  
(note any changes in classes etc. have to be by Jan 2)

Performance Scent Dogs is the new registry and certifying organization for the dog sport of scent detection. To compete, dogs must be registered with Performance Scent Dogs (PSD). Registration can be done instantly, online, at [www.performancescentdogs.com](http://www.performancescentdogs.com) or by mail - \$30.00 payable to Performance Scent Dogs along with the name, breed, date of birth of the dog, and your information (name, address, phone number, email) – **Performance Scent Dogs, Inc., PO Box 401226, Cambridge, MA, 02140**. The \$30.00 registration cost is for the lifetime of the dog. You do not have to be a member, PSD registers dogs, not handlers.

***Try Before Your Buy! Enter the trial without paying for dog registration. If you enjoy your experience at this PSD trial, register within 7 days after the trial to keep your results.***

\*Pick and choose what classes are right for your dog\*

\*Videotaping allowed\* Earn legs toward titles\* Competitor feedback encouraged \*Watch and root for other competitors\* Spend time with your dog in a welcoming atmosphere\*

***\*Turn any search, at any time, into training by asking the judge the location of the hide\****

**No rush, show up about 8:30 to 8:45**

**Final run order will be announced with entry confirmation email.**

**Venue** Limited indoor crating may be available. Vehicle crating is preferred. (but safety first) Tova Training reserves the right to remove any individual for any reason from the premises. Dogs must be kept on leash, crated or safely confined in the vehicle at all times (not in a chair, not in a mat, not alone anywhere, not in a hat) (unless on a search that is approved to be leash optional).

**Collars** Any collar is allowed on the grounds except electronic or scent spraying collars. Only a flat, or martingale collar or leashes attached to a dead ring or harness are permitted to be used during a search. **No tags on collars while searching.** All dogs must be leashed at all time, except during an off-leash search. Flexi-leads on acceptable on trial grounds **unless** you are found to not be paying attention to spatial needs of other dog teams. You must remain vigilant so all teams may have a pleasant experience.

**Parking** Plenty of parking. Please watch for cone or signs indicating an area is off limits for parking-it may be a search area.

**Volunteers** will help our Trial run smoothly. We need Timers, Gate Stewards, Score Runners, and Others. No Experience Required! Please contact the Volunteer Coordinator, Jean MacKenzie, by email ([tovatraining@gmail.com](mailto:tovatraining@gmail.com)) to sign up for the volunteer job of your preference. Thanks in advance for your help.

**Food** There are fast food/pizza places in the plaza and other dining options nearby. We encourage snacks and potluck so if you wish to share.. please do!!!

**Facility, Bathrooms and Water** We have an indoor porta potty but no running water, bring water for you and your dog.

**Accessibility** No stairs or steps for entry. Email the Trial Secretary for more information.

**Dogs In Need of Space (DINOS)** are welcome. The site has plenty of parking and places to walk dogs at a distance of 12 feet or more. Volunteers will be onsite to help escort participants to and from the search area. All persons should be sensitive and respectful to all dog's spatial needs. A red bandana is preferred for dogs in need of extra space.

**Handler running multiple dogs** A handler can run multiple dogs in TOTs at any trial. In this trial a handler can run one dog at the Novice, Advanced and Excellent level. Additional dogs in the same class may be entered to run FEO.

**Who can compete?** Any and all dogs that are 12 months or older, on the day of the trial or the Target Odor Test (TOT), are eligible to compete. Dogs with disabilities are welcome. Please review the rules for proper steps to enter dogs with disabilities.

**What if I don't pass the TOT?** You can still play!! Dogs must pass a Target Odor Test (TOT) in order to compete in the Standard Division, however if you do not pass you are still allowed to enter the trial as FEO (For Exhibition Only) for the day.

**My dog has a title from a different scent detection organization (i.e. Nose Work), do I have to pass a TOT?** If you already have passed an odor test in another scent work organization you do not have to take the TOT. In addition, dogs with a NW3, SDDA Excellent or UKC Level 5 title may skip the Novice level and start PSD at the Advanced level. Please send a copy of your test results to PSD when registering to enter the trial.

**Do I have to compete in every class at every trial?:** Dogs do not have to compete in all classes to participate in the trial.

**If I successfully title in one class, must I stay in that class level until all 5 classes are finished at that level?** When successfully completing one class title, you may move up to the next class level. You are not required to complete all classes first. For example, you finish title requirements in Exteriors but not in Distance. You may move up to Advanced Exteriors while continuing to compete in Novice Distance.

**Can I watch other competitors?** Yes, you can watch, either after you run or you can watch a different level compete.

**Can my friend videotape my searches?** Yes! And you may post them anywhere you like once the class is over.

**Awards:** Placement ribbons will be awarded for 1<sup>st</sup>-3<sup>rd</sup> place in all classes. Ribbons will be awarded for Q's in all classes to those that qualify.

#### **Notice to Exhibitors:**

- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- Please be courteous and pick up after your dog. If you don't pick up after your dog, you will be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when allowable at the search site.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- **All entries must be accompanied by entry fees to be valid.** If you haven't paid by closing, your entry will be deleted. A declined payment or returned check does not constitute a valid entry. There will be a \$50.00 fee for any returned check or payment. Checks are made payable to Tova Training.
