### **Fun Facts about PSD**

- \*Pick and choose what classes are right for your dog\* - \*Videotaping allowed\* \*Earn legs toward titles\*
- \*Competitor feedback encouraged\* - \*Watch and root for other competitors\*
- \*Turn any search at any time into training by asking the judge the location of the hide\*
- \*Enter more than one dog\* - \*Spend time with your dog in a welcoming atmosphere\*

**Come and have FUN with your dog!**

**Who can compete in a trial/match?** Any and all dogs that are 10 months or older, on the day of the trial/match or the Target Odor Test (TOT), are eligible to compete. Dogs with disabilities are welcome. Please review the rules for proper steps to enter dogs with disabilities.

**Do I Need to Register with PSD?** PSD registers dogs not people. A \$30 registration fee is good for the lifetime of the dog and can be done instantly on-line.

**What if I don't pass the TOT?** You can still play!! Dogs must pass a Target Odor Test (TOT) in order to compete in the Standard Division, however if you do not pass you are still allowed to enter the trial as FEO (For Exhibition Only) for the day.

**My dog has a Nose Work title from a different organization, do I have to pass a TOT?** If you already have passed an odor test in another scent work organization, you do not have to take the TOT. Dogs with a NW3, SDDA Excellent or UKC Level 5 title may skip the Novice level and start PSD at the Advanced level. Please send a copy of your test results to [info@performancescentdogs.com](mailto:info@performancescentdogs.com) in order to register.

**Do I have to compete in every class element at every trial?** Dogs do not have to compete in all five class elements to participate in the trial.

**If I successfully title in one element, must I stay in that class level until all 5 classes are finished at that level?** When successfully completing one class element title, you may move up to the next class level. You are not required to complete all class elements first. For example, if you finish title requirements in Exterior but not in Containers. You may move up to Advanced Exterior while continuing to compete in Novice Containers.

**Can I watch other competitors?** Yes you can watch, either after you run or you can watch a different level compete.

**Can my friend videotape my searches?** Yes! And you may post them anywhere you like once the judge calls, "All clear".

### **Cancellations/Move-Ups/Changes/Refunds:**

- Cancellations received on or before the closing date, May 16, 2019, will receive a full refund.
- Cancellations received after the closing date, May 16, 2019, will **not** receive a refund.
- If you earn a title in the entered class before this trial, please contact the Trial Secretary no later than May 16, 2019, in writing via email for move-ups.
- Next day move-ups for those who qualify at this trial from Novice to Advanced are allowed, but must be submitted before 5 pm on Saturday to the Trial Secretary.
- Changes, except for move-ups, requested after the closing date, May 16, 2019, will incur a fee of \$5.00 *per change*.

**Trial Fees:** TOTs: \$15.00 each; Classes: \$20.00 each

### **Tentative Run Order for Both Days:**

- Containers 1 to Speed
- Containers 2 to Exterior
- Distance to Buildings

**Novice classes will run first after TOTs with Advanced classes not starting prior to 12:00pm.**

**Awards:** Rosette placement ribbons will be awarded for 1<sup>st</sup> - 3<sup>rd</sup> place in the Standard division. Placement ribbons will also be awarded for 1<sup>st</sup> - 3<sup>rd</sup> place in the Metallic division. Ribbons will be awarded for Q's in all classes, including TOT's. Title ribbons will also be available in both the Standard and Metallic divisions.

**Iron Nose Award/SUPER Iron Nose Award:** We will be offering an "Iron Nose Award" to those dogs who qualify in every standard PSD class offered each day (Containers/Speed/Exterior/Distance/Buildings). We will also be offering a "**SUPER** Iron Nose Award" to those dogs who earn an "Iron Nose Award" BOTH days. FEO runs are not eligible to be counted for these awards. (Yes, you have two chances in Containers each day!)

**Collars:** Any collar is allowed on the grounds except scent spraying, choke and electronic collars. Only a flat, or martingale collar or leashes attached to a dead ring or harness are permitted to be used during a search. No tags on collars while searching. All dogs must be leashed at all times, except during an off-leash search.

**Crating:** There is no crating allowed in the building. Be aware cars will **NOT** be allowed to idle in order to run their heat/air conditioning. Be prepared to roll down windows (if warm)/keep windows up (if cool) and/or equipped with adequate vehicle shades/crate fans, etc. for working out of your vehicle. Please be courteous to other exhibitors.

**Parking:** Parking must be in the school parking lot. There is no on-street parking allowed. Please watch for cones or signs indicating an area is off limits for parking - it may be a search area. Please respect volunteers who may be asked to assist with parking organization.

**Spectators:** Anyone is invited to come and watch a PSD trial or a match.

**Volunteers:** Volunteers will help our trial run smoothly. We need Timers, Gate Stewards, Score Runners, and others. No experience required! No need to give up a day - volunteers get to run first in their class. Lunch will be provided to all workers. Complete the [online Volunteer Form](#) to sign up!

**Food:** Lunch will only be available for judges and volunteers but there are plenty of convenience stores/fast food restaurants close to the trials.

**Facility, Bathrooms and Water:** Climate controlled toilets and non-potable water available on site. Please plan to bring your own water for you and your dog to drink.

**Accessibility:** One step into building for entry and one step out to exterior search area. Bathrooms only accessible by stairs. Email the Trial Secretary for more information.

**Dogs In Need of Space (DINOS):** The site has plenty of parking and places to walk dogs at a distance of 10 feet or more. There is a single entrance and exit for interior searches that could be congested. Volunteers will be onsite to help escort participants to and from the search area. Red bandanas are encouraged - please give **all** dogs space.

**Handler running multiple dogs:** A handler can run multiple dogs in TOTs at any trial/match. **At these trials, a handler may only run one dog in each class.** A second or third dog can run FEO.
