- If you earn a title in the entered class before this trial, please contact the trial secretary no later than March 11, 2019, in writing via email for move-ups.
- Next day move-ups for those who qualify at this trial from Novice to Advanced and/or Advanced to Excellent are allowed, but must be submitted before 5 pm on Saturday to the Trial Secretary.

Fun Facts about PSD

*Pick and choose what classes are right for your dog * Videotaping allowed * Earn legs toward titles * Competitor feedback encouraged * Watch and root for other competitors * Turn any search at any time into training by asking the judge the location of the hide * Enter more than one dog* Spend time with your dog in a welcoming atmosphere*

Come and have FUN with your dog!

Who can compete in a trial? Any and all dogs that are 10 months or older, on the day of the trial or the Target Odor Test (TOT), are eligible to compete. All dogs must have their current rabies vaccination and other vaccinations recommended by your veterinarian.

Do I Need to Register with PSD? PSD registers dogs not people. A \$30 registration fee is good for the lifetime of the dog and can be done instantly on-line.

What if I don't pass the TOT? You can still play!! Dogs must pass a Target Odor Test (TOT) in order to compete in the Standard Division, however if you do not pass you are still allowed to enter the trial as FEO (For Exhibition Only) for the day.

My dog has a Nose Work title from a different organization, do I have to pass a TOT? If you already have passed an odor test in another scent work organization, you do not have to take the TOT. Dogs with a NW3, SDDA Excellent or UKC Level 5 title may skip the Novice level and start PSD at the Advanced level. **Please send a copy of your test results to info@performancescentdogs.com in order to register.**

Can I watch other competitors? Yes you can watch, either after you run or you can watch a different level compete.

Can my friend videotape my searches? Yes! And you may post them anywhere you like.

Awards: Rosette placement ribbons will be awarded for 1st - 3rd place in the Standard division. Placement ribbons will also be awarded for 1st – 3rd place in the Metallic division. Ribbons will be awarded for Q's in all classes, including TOT's. Title ribbons will also be available in both the Standard and Metallic divisions.

Iron Nose Award: We will be offering an "Iron Nose Award" to those dogs who qualify in all classes offered each day.

After entering online you may choose to mail a check instead of paying online by credit card by choosing the "Pay Later" option. Please mail the checks to the trial secretary listed below. Please note that each day is considered a separate trial. To enter both days you will have to click on the link for the individual dates and enter each day separately. If paying by credit card instead of check, you will be charged for each day in a separate transaction. To redeem K-9 Scent Crew worker bucks you earned from a previous trial, please choose the "pay later" option and remit your check for the remaining balance (minus the amount of worker bucks).

Collars: Any collar is allowed on the grounds except scent spraying collars. Only a flat, or martingale collar or leashes attached to a dead ring or harness are permitted to be used during a search. No tags on collars while searching. All dogs must be leashed at all times, except during an off-leash search.

Crating: Indoor crating is not available at this trial. Please make arrangements to crate inside your vehicle. The parking lot is not shaded so please make sure you bring fans, shade cloths, etc. to keep your dogs cool & comfortable. There will be one parking space per competitor

vehicle. Anything used for shade must be contained within that specific parking space. Dogs must be crated or kept comfortably in your vehicle while not running or pottyng.

Parking: There will be someone to direct you to the parking area. Please watch for cones or signs indicating an area is off limits for parking-it may be a search area. Spectator only parking will be located in a separate lot from the competitor parking.

Spectators are invited to come and watch a PSD trial or a match.

Volunteers will help our Trial run smoothly. We need Timers, Gate Stewards, Score Runners, and others. No experience is required! Please e-mail the Trial Secretary if you wish to volunteer. Volunteers will receive a \$2 voucher for each full class they work. The tickets can be used towards entry fees at a future K-9 Scent Crew trial.

Donations: We will be selling tickets for a raffle basket to support a local cause. More details to follow closer to the trial.

Food: There are a number of fast-food restaurants located within a two mile radius of the trial site for lunch or you may want to bring your own.

Facility, Bathrooms and Water: The facility is climate controlled with indoor bathrooms. There is no smoking allowed at this facility, including e-cigarettes. Also, please make sure to pick up after your dogs.

Accessibility: No stairs or steps for entry. There could be stairs to access certain search areas. This facility is handicapped accessible. Email the TS for more information.

Dogs In Need of Space: The site has plenty of parking and places to walk dogs at a distance of 10 feet or more. Volunteers will be onsite to help escort participants to and from the search area. Red bandanas are encouraged - ***please give all dogs space.***

Dogs in Season: Females in season may participate wearing appropriate britches at all times except in the toileting areas. Females in season will run after the last dog in each search area. Handlers must notify the club as soon as possible so accommodations may be made for toileting areas and run order adjustments.

Handler running multiple dogs: A handler can run multiple dogs in TOTs at any trial/match. At this trial, a handler may only run one dog in each class. A second or third dog can run FEO or in a different class.
