**Performance Scent Dogs** is a national scent work non-profit organization dedicated to growing the sport of scent detection.

The PSD Rulebook can be found at www.performancescentdogs.com *Please be sure to review it before entering and trialing* 

Performance Scent Dogs is a registry and certifying organization for the dog sport of scent detection. Teams can compete without being registered with Performance Scent Dogs, however in order to see results and qualify for titles, **dogs** must be registered with Performance Scent Dogs (PSD). **Registration** can be done instantly, online, at www.performancescentdogs.com or by mail - \$30.00 payable to Performance Scent Dogs along with the name, breed, date of birth of the dog, and your information (name, address, phone number, email) – **Performance Scent Dogs, Inc., PO Box 401026, Cambridge, MA, 02140**. The \$30.00 registration cost is for the lifetime of the dog. **You do not have to be a member, PSD registers dogs, not handlers.** 

\*Pick and choose what classes are right for your dog\* \*Videotaping allowed\*Earn legs toward titles\*Competitor feedback encouraged \*Watch and root for other competitors\*Spend time with your dog in a welcoming atmosphere\* \*Turn any search, at anytime, into training by asking the judge the location of the hide\* Come and have FUN with your dog!



### Doors open at 8:00 am for sign-in Judge's Briefing at 8:30 am First dog on the line at 9:00 am

**Venue** There will be no indoor crating. Vehicle crating is required. This is a no-smoking establishment. The trial committee reserves the right to remove any individual for any reason from the premises. Dogs must be kept on leash, crated or safely confined in the vehicle at all times (unless on a search that is approved to be leash optional).

**Collars** Any collar is allowed on the grounds except electronic or scent spraying collars. Only a flat, or martingale collar or leashes attached to a dead ring or harness are permitted to be used during a search.

**No tags on collars while searching**. All dogs must be leashed at all time, except during an off-leash search. "Flexileads are acceptable on trial grounds unless you are found to not be paying attention to spatial needs of other dog teams. You must remain vigilant so all teams may have a pleasant experience.

**Parking:** Parking available in the lot in front of the property on N Chet St and on the property owned by Greatland Welding, just behind the trial location. RV parking and overnight camping will be available there as well. **THERE ARE NO HOOKUPS FOR WASTE OR ELECTRICITY. They are letting us use their land, so please keep it clean and pack out everything you bring in.** Please watch for cone or signs indicating an area is off limits for parking.

**Volunteers** will help our Trial run smoothly. At the trial we will need traffic, gate stewards, timers, and score runners. Are you willing to take pics or videos for competing teams? Do you want to help with hospitality? Lots of fun to help and play!!!! Please email our volunteer coordinators at: mailto:thojelab@gmail.com

Food and Fun: The hosts will provide Coffee, tea, water, light breakfast, and lunch items. Please bring a side or dessert to share. We have designated H.E.L.P. https://www.facebook.com/pg/Helping-Escaped-Lost-Pets-Help-487210078301345 as our charity for this trial and will have a donation container available.

Facility, Bathrooms and Water Climate controlled, water and bathrooms available on site.

**Accessibility** Handicap accessible parking will be available in front of the venue. Please let us know if you will need that so we can reserve enough spaces. Some searches will be outside on pavement, gravel or uneven ground. Greatland Welding has lots of large flat areas good for potty and walking. As always, please pick up after your dog.

**Dogs In Need of Space (DINOS)** are welcome. Parking for handlers with Dogs in need of space (reactive or in heat) will be marked and volunteers can help guide you there. Walk dogs at a distance at 10Ft. Volunteers will be onsite to help escort participants to and from the search area. All persons should be sensitive and respectful to all dog's spatial needs. A red bandana is preferred for dogs in need of extra space.

**Handler running multiple dogs** A handler can run multiple dogs in TOTs at any trial. At this trial, a handler may participate in only one qualifying search per class. If an alternate handler is available to run the 2<sup>nd</sup> dog, they may both earn qualifying searches in that level. One person can run one dog per level or one person can run each dog in separate levels.

**Who can compete?** Any and all dogs that are 10 months or older, on the day of the trial or the Target Odor Test (TOT), are eligible to compete. Dogs with disabilities are welcome. Please review the rules for proper steps to enter dogs with disabilities.

What if I don't pass the TOT? You can still play!! Dogs must pass a Target Odor Test (TOT) in order to compete in the Standard Division, however if you do not pass you are still allowed to enter the trial as FEO (For Exhibition Only) for the day.

**My dog has a title from a different scent detection organization (i.e. Nose Work), do I have to pass a TOT?** If you already have passed an odor test in another scent work organization you do not have to take the TOT Please include a copy of your test results when entering the trial.

**Do I have to compete in every class element at every trial?** Dogs do not have to compete in all five class elements to participate in the trial.

If I successfully title in one element, must I stay in that class level until all 5 classes are finished at that level? When successfully completing one class element title, you may move up to the next class level. You are not required to complete all class elements first. For example, you finish title requirements in Buildings but not in Exterior. You may move up to Advanced Buildings while continuing to compete in Novice Exterior. **The sign up sheet for move-ups will be available on Saturday for those who complete an element and wish to move up. This must be requested no later than the end of the ribbon ceremony on Saturday**. This will allow us time to adjust the teams in the computer and on run orders.

**Can I watch other competitors?** Yes, you can watch, either after you run or you can watch a different level compete.

**Can my friend videotape my searches?** Yes! And you may post them anywhere you like once the judge calls "All Clear."

**Awards:** Ribbons will be awarded for Q's in all classes to those that qualify. Rosette placement ribbons will be awarded for 1<sup>st</sup>-3<sup>rd</sup> place in Novice, Advanced and Excellent classes.. Perfect Day and Rising Star ribbons will be awarded. Metallic placement ribbons will be awarded for dogs competing in metallic divisions.

#### 2 ways to enter

**Method of entry by mail**: complete the Entry form, sign the Release of Liability, and mail it to the Trial Secretary along with your **check made payable to The Better Companion LLC**.

**Method of entry online at www.performancescentdogs.com** Go to the list of trials and click on the one you want to enter to be taken to the sign up page.

Entries will be taken on a first-received basis and must be received by 6:00 pm AST on April 15, 2019.

#### Notice to Participants:

- Participants are responsible for complete, accurate and legible information on their entry forms.
- Participants are responsible for reading and signing the Release of Liability form when checking in. You may use one form for both days.
- It is expressly understood that participants alone are responsible for behavior of their dogs, children and/or guests. Any participant whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- Please be courteous and pick up after your dog. If you don't pick up after your dog, you may be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when allowable at the search site.
- Participants are responsible for being in the staging area when it is their turn to run. All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$50.00 fee for any returned check or payment.
