
Performance Scent Dogs is a registry and certifying organization for the dog sport of scent detection. **Register** your dog online, at [www.performancescentdogs.com](http://www.performancescentdogs.com) or by mail - \$30.00 payable to Performance Scent Dogs along with the name, breed, date of birth of the dog, and your information (name, address, phone number, email) **Performance Scent Dogs, Inc., PO Box 401026, Cambridge, MA, 02140**. The \$30.00 registration cost is for the lifetime of the dog.  
**PSD registers dogs, not handlers.**

**Venue Rules and Parking:** Indoor crating will not be available at this time. Vehicle crating is required. This is a no-smoking establishment. The trial committee reserves the right to remove any individual for any reason from the premises. Dogs must be kept on leash, crated or safely confined in the vehicle at all times (unless on a search that is approved to be leash optional). Upon arrival, you will be directed to parking area.

**Facility, Bathrooms and Water** Kitchenette, Water and bathrooms available on site.

**Accessibility** Handicap accessible parking and DINO (Dogs in need of space or in heat) will be available. Please let us know in advance, if you will need special parking arrangements, so we can reserve enough spaces. Access to search areas will be outside on gravel paths and uneven ground.

**Volunteers** will help our Trial run smoothly. At the trial we will need traffic, gate stewards, timers, and score runners. Are you willing to take pics or videos for competing teams? **Food:** The hosts will provide Coffee, tea, water, paper plates and utensils. Please sign up with our hospitality coordinator..... TBD..... to bring a main, side or dessert to share.

**Designated Charity:** We have designated <https://www.alaskasolsticesearchdogs.com/> as our charity for this trial and will have a donation container available.

**Collars** Any collar is allowed on the grounds except electronic or scent spraying collars. Only a flat, or martingale collar or leashes attached to a dead ring or harness are permitted to be used during a search. **No tags on collars while searching.** All dogs must be leashed at all time, except during an off-leash search. "Flexileads are acceptable on trial grounds unless you are found to not be paying attention to spatial needs of other dog teams. You must remain vigilant so all teams may have a pleasant experience.

**Dogs In Need of Space (DINOS)** are welcome. If handlers would like to take advantage of a separate parking area for dogs in need of space or dogs in heat, volunteers will guide you there. Please walk dogs at a distance at 10Ft. Volunteers will be onsite to help escort participants to and from the search area. All persons should be sensitive and respectful to all dog's spatial needs. A red bandana is preferred for dogs in need of extra space.

**Handler running multiple dogs** A handler can run multiple dogs in TOTs at any trial. At this trial, a handler may participate in only one qualifying search per class. If an alternate handler is available to run the 2<sup>nd</sup> dog, they may both earn qualifying searches in that level. One person can run one dog per level or one person can run each dog in separate levels.

**Who can compete?** Any and all dogs that are 10 months or older, on the day of the trial or the Target Odor Test (TOT), are eligible to compete. Dogs with disabilities are welcome. Please review the rules for proper steps to enter dogs with disabilities. As always, please pick up after your dog.

**What if I don't pass the TOT?** You can still play!! Dogs must pass a Target Odor Test (TOT) in order to compete in the Standard Division, however if you do not pass you are still allowed to enter the trial as FEO (For Exhibition Only) for the day.

**My dog has a title from a different scent detection organization (i.e. Nose Work), do I have to pass a TOT?** If you already have passed an odor test in another scent work organization you **do not** have to take the TOT Please include a copy of your test results when entering the trial.

**Do I have to compete in every class at every trial?** Dogs do not have to compete in all five classes to participate in the trial.

**If I successfully title in one class, must I stay in that class level until all 5 classes are finished at that level?**

When successfully completing one class title, you may move up to the next class level. You are not required to complete all classes first. For example, you finish title requirements in Buildings but not in Exterior. You may move up to Advanced Buildings while continuing to compete in Novice Exterior.

**The sign-up sheet for move-ups will be available on Saturday for those who complete a class and wish to move up. This must be requested no later than the end of the ribbon ceremony on Saturday.** This will allow us time to adjust the teams in the computer and on run orders.

**Can I watch other competitors? Can my friend videotape my searches?** Yes, you can watch, either after you run or you can watch a different level compete. You may post videos them anywhere you like once the judge calls "All Clear."

**Awards:** Ribbons will be awarded for Q's in all classes to those that qualify. Rosette placement ribbons will be awarded for 1<sup>st</sup>-3<sup>rd</sup> place in Novice, Advanced and Excellent classes. Perfect Day and Rising Star ribbons will be awarded. Metallic placement ribbons will be awarded for dogs competing in metallic divisions.

**2 ways to enter**

**Method of entry by mail:** complete the Entry form, sign the Release of Liability, and mail it to the Trial Secretary along with your **check made payable to Valley K9 Sports (VK9S).**

**Method of entry online at [www.performancescentdogs.com](http://www.performancescentdogs.com)** Go to the list of trials and click on the one you want to enter to be taken to the sign up page. Entries will be taken on a first-received basis and must be received by 6:00 pm AST on Aug 28, 2019.

**Notice to Participants:**

- **Participants are responsible for complete, accurate and legible information on their entry forms.**
- **Participants are responsible for reading and signing the Release of Liability form when checking in. You may use one form for both days.**
- **It is expressly understood that participants alone are responsible for behavior of their dogs, children and/or guests. Any participant whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.**
- **Please be courteous and pick up after your dog. If you don't pick up after your dog, you may be asked to leave the trial site. In such case, no refund on any entry will be made.**
- **All dogs must be on leash at all times except when allowable at the search site.**
- **Participants are responsible for being in the staging area when it is their turn to run. All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$50.00 fee for any returned check or payment.**
