## Come and have FUN with your dog!

**Who can compete?** Any and all dogs that are 10 months or older, on the day of the trial or the Target Odor Test (TOT), are eligible to compete.

What if I don't pass the TOT? You can still play!! Dogs must pass a Target Odor Test (TOT) in order to compete in the Standard Division, however if you do not pass you are still allowed to enter the trial as FEO (For Exhibition Only) for the day.

My dog has a Nose Work title from a different organization, do I have to pass a TOT? If you already have passed an odor test in another scent work organization you do not have to take the TOT. Dogs with a NW3, SDDA Excellent or UKC Level 5 title may skip the Novice level and start PSD at the Advanced level. Please send a copy of your test results to PSD in order to register.

**Awards:** Rosette ribbons will be awarded for standard 1<sup>st</sup>-3<sup>rd</sup> place in addition to Class Titles, and Level Titles. Ribbons will be awarded for Q's in all classes and Metallic Level 1<sup>st</sup>-3<sup>rd</sup> place. The GSDC-

SNH will be giving away special awards to the fastest search completed by a GSD and the fastest completed by a non-GSD at each level.

Fees: Birch, Anise and Clove TOT - \$15.00; All Level Classes - \$20.00.

**Collars** Any collar is allowed on the grounds except electronic or scent spraying collars. Only a flat, or martingale collar or leashes attached to a dead ring or harness are permitted to be used for searches. All dogs must be leashed at all times, except during an off-leash search. No tags are allowed on a collar during a search.

Crating No, not this time

**Volunteers** will help our Trial run smoothly. We need Timers, Gate Stewards, Score Runners, and Others. No Experience Required! **Volunteers Run FIRST in each class!** Thanks in advance for your help.

**Parking** Parking in the lot is limited, but there is parking along the street which is very quiet. Please watch for cone or signs indicating an area is off limits for parking-it may be a search area. This trial will run by level (All Novice classes, then Advanced classes, and then Excellent classes).

Spectators – during COVID times, we are only allowing competitors on site

#### Food No onsite food available

Bathrooms and water Full service bathrooms available inside.

**Venue and Accessibility** This building does have stairs that may lead to search areas and to the crating room. Some searches may be outside on pavement or rough ground. Please email the trial secretary for details.

**Dogs In Need of Space** The site has plenty of parking and places to walk dogs at a distance of 20 feet or more. There is a separate entrance and exit area. Volunteers will be onsite to help escort participants to and from the search area. A red bandana is encouraged, but please give <u>all</u> dogs space.

**Handler running multiple dogs** A handler *can* run multiple dogs in TOTs at any trial. At this trial, handlers may run one dog in any of the classes at any level. A second dog may run FEO. This could change depending on the number of competitors and will be determined the week of the trial.
