Pick and choose what classes are right for your dog • Videotaping allowed • Earn legs towards titles • Competitor feedback encouraged • Turn any search at any time into training by asking the judge the location of the hide • Spend time with your dog in a welcoming atmosphere •

- **Who can compete in a trial?** Any and all dogs that are 10 months or older on the day of their TOT or trial are eligible to compete. All dogs must have their current Rabies vaccination.
- **Do I need to register with PSD?** PSD registers dogs, not people. A \$30 registration fee is good for the lifetime of the dog and can be done instantly online.
- **What if I don't pass the TOT?** You can still play!! Dogs must pass a Target Odor Test (TOT) in order to compete in the Standard Division, however if you do not pass you are still allowed to enter the trial as FEO (For Exhibition Only) for the day.
- **My dog has a Nose Work title from a different organization; do I have to pass a TOT?** If you have already passed an odor test in another scent work organization you do not have to take the TOT. Dogs with an NW3, SDDA Excellent or UKC Level 5 title may skip the Novice level and start PSD at the Advanced level. Please send a copy of your test results to the trial secretary in order to register.
- **Can I watch other competitors?** From outside the search area, with social distancing.
- **Can my friend videotape my searches?** Yes! And you may post them when that class is complete and the judges declare all clear.
- **Awards:** Rosette placement ribbons will be awarded for 1st-3rd place in Standard division. Rosettes will be awarded for new class titles and level titles. Ribbons will be awarded for Q's in TOTs and all Standard division classes..
- **Spectators** can observe exterior classes, at a proper social distance.
- **Fees:** Birch, Anise, and Clove TOTs are \$25.00 each, and each class offered is \$20.00.

EXTRA COVID-19 NOTES

- **Gate Sheets:** We will do a "roll call" Type of check in, just call out peoples' names, so ONLY the Gate steward touches that classes board.
- **Gate steward** MUST stay 6' away. No exhibitors touching the gate sheets or pens etc
- **Run Order** will be emailed to each competitor. Please print and bring with you to the trial.
- **Crating** only in your car, NO INDOOR Crating; **pop up tents are good.** Be sure to park in the crating-approved parking spaces.
- **Food:** NO hospitality (our apologies), please bring your own food and drink.
- **Ribbon table** will be set up outside, ONE person will be handling the ribbons. No more than 5 people standing in line for the ribbon; please use social distancing of 6' and don't forget to wear your mask. The ribbon person will wear a mask and have disinfectant. Please pick up your Q ribbons right after your runs.
- **Results:** Trial Secretary will email the trial results.
- **LINE UP TO RUN:** There will be distance marks for where to stand.

- In accordance with CDC guidelines, **people who are not fully vaccinated are required to wear face masks inside. Outside masks are required only where social distancing is not possible.** Exhibitors will need to bring enough masks for the duration of the trial and dispose of single use masks properly. If you are unable to wear a mask for a medical reason, please bring a copy of your doctor's note exempting you from wearing your mask.
- **Sanitizer:** There will be sanitizer available.

Collars - No electric, choke, or spray collars are allowed at this trial. Also, no flexi-leashes are allowed on the property. For searches, only a flat or martingale collar, or leash attached to a harness are permitted to be used. You may use a long line. **NO TAGS allowed on collars** while searching; tags may, however, be attached to harnesses.

Crating - Crating will be in or next to your car.

Parking - The parking area is in the mowed pasture. Feel free to bring a pop up tent and chair.

Bathrooms - Inside Leslie's house.

Accessibility - The buildings is easily accessible but walking through grassy areas is necessary. Some searches will be outside on pavement or rough ground.

Dogs In Need of Space (DINOS) - The site has plenty of parking and places to walk dogs at a distance of 10 feet or more. There will be separate entrance and exit. Expect dogs to be with their owners at times or on the way to or from searches. Email the trial secretary with questions.

Handler running multiple dogs A handler can run multiple dogs in TOTs at any trial. At this trial, handlers may run one dog in any of the classes at any level. For info about running a second dog, please contact the trial secretary.

Volunteers will help our trial run smoothly. We need Timers, Gate Stewards, Score runners, and others.

No experience required! Volunteers get to run first in their class. Thanks in advance for your help!
